SMOKING POLICY

Club Commitment

- The YP Dirt Kart Club Inc recognises that environmental tobacco smoke is a health hazard and that non-smokers and minors should be protected from it.
- The Smoking Policy has been developed within the recommended guidelines of Government of South Australia, SA Health Department for Sporting and Recreational Organisations and the Tobacco Products Regulation Act 1997 (SA).
- The Smoking Policy applies to YP Dirt Kart Club Inc members, all visiting AIDKA members, officials, volunteers and spectators.
- This policy has not been developed as a personal attack on smokers, but to minimise the effect their smoking has on the health of others.

Smoke Free Zones

Smoking is strictly not permitted in the following areas:

- In the Clubhouse
- In any enclosed building at the venue
- In any Club owned, hired or borrowed vehicles, plant or equipment.
- Within the pit area, race arena, and red zone as per AIDKA Rules of Racing
- In outdoor spectator grandstands or seated areas
- In outdoor food or drink outlets
- In congested outdoor areas or walk ways
- In child designated areas, including playgrounds.

Smoking Permitted Zones

Smoking will be permitted in the following areas:

Outside the exterior fence line of the pit area and track arena.

Promoting the Health Benefits of Non Smoking

• The Club will have access to various education material and signage to promote the benefits of non-smoking and health risks of passive smoking.

Member Commitment

All members and associated persons are required to comply with the following.

- AIDKA Rules of Racing (Drug and Alcohol Policy)
- Respect a person's choice not to smoke or be subject to passive smoking.
- Protect minors from passive smoking.

Non-Compliance

All persons are reminded that this policy's designated smoke free zones are supported by the legislative requirements of the Tobacco Products Regulation Act 1997 (SA). Part 4 of this Act outlines specific contraventions and the penalties.

Any person found in breach of this policy, will be approached by the Clerk of the Course Steward or Club Official. They will be reminded about the non-smoking policy and asked to move to a smoking area or extinguish their cigarette. If smoking continues, the Course Steward will repeat the verbal request and inform the patron that they will be escorted from the venue, should they continue to smoke.

Any person repeatedly in breach of this policy will face disciplinary action as outlined in our Member Protection Policy and Procedures or Code of Conduct.

Review

This policy will be reviewed annually to ensure that the policy remains current and practical.

Agreement

To be a financial member requires annually a signed membership form and annual fees paid, which confirms that the member has read, understood and agrees to abide by this policy which operates in conjunction with the Code of Conduct Policy.
